Sub. Continuance of Recognition of MBBS degree granted by Dr. NTR University of Health Sciences, Vijayawada in respect of students being trained at Mamata Medical College, Khammam, Telangana.

Sir/ Madam,

I am directed to inform that an assessment of the physical and the other teaching facilities available for continuance of recognition of MBBS degree granted by Dr. NTR University of Health Sciences, Vijayawada in respect of students being trained at Mamata Medical College, Khammam, Telangana was carried out by the Council Assessors on 21st& 22nd July, 2016. The assessment report (21st& 22nd July, 2016) alongwith complaint dated 18.05.2016 received from Shri Mandadapu Sudhakar, Khammam, Telangana was considered by the Executive Committee at its meeting held on 23.08.2016. The following recommendations of the Executive Committee was approved by the General Body of the Council at its meeting held on 22nd November, 2016:-

"The Executive Committee of the Council considered the assessment report (21st& 22nd July, 2016) along with complaint dated 18.05.2016 received from Shri Mandadapu Sudhakar, Khammam, Telangana and decided to recommend that recognition of MBBS degree granted by Dr. NTR University of Health Sciences, Vijayawada in respect of students being trained at Mamata Medical College, Khammam, Telangana be continued restricting the number of admission to 150 (One Hundred Fifty) students."

The General Body of the Council further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April, 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute.

The above decision of the General Body has been approved by the Oversight Committee on 28.04.2017.
