While applying for such renewal, the achievement in terms of infrastructure, staff and equipment as spelt out in the time bound action plan and as required by Medical Council of India norms must be clearly indicated. The next batch of students against the increased intake shall not be admitted unless renewal of permission is granted by the Central Government.

The admission process for the academic year 2006-07 has to be completed in accordance with the time schedule indicated in the Graduate Medical Education Regulation, 1997, as amended.
