I am directed to refer to your application for grant of Continuation of Recognition of MBBS degree (150 seats) awarded by Kaloji Narayana Rao University of Health Sciences, Warangal, Telangana in respect of the students being trained at Mamata Medical College, Khammam, Telangana and to say that your college was assessed by the Assessors appointed by MARB to conduct virtual assessment on the conduct of examination on 15th June, 2022 and physical verification of the facilities on 6th December, 2022. Both the assessment reports were considered in the Undergradute Medical Education Board, an autonomous Board of the Commission.

- 2. Accordingly, your application for grant of Continuation of Recognition of MBBS degree (150 seats) awarded by Kaloji Narayana Rao University of Health Sciences, Warangal, Telangana in respect of the students being trained at Mamata Medical College, Khammam, Telangana has been considered in Under Graduate Medical Education Board (UGMEB). While evaluating both the reports alongwith the AEBAS and HMIS data including CCTV, certain deficiencies were noted and the same were communicated to the college authorities vide UGMEB's letter dated 06.06.2023 for compliance.

Subsequently, an opportunity of the personal hearing was also given to the college authoritites on 21.06.2023.
- 4. After hearing the college authorities and careful consideration of the facts and compliance, it has been decided by the Under Graduate Medical Education Board (UGMEB) that Mamata Medical College, Khammam is granted **one year** recognition to the MBBS qualification in respect of the students admitted in the year 2018-19. However, they shall apply afresh for recognition/approval in 2024.

- 5.
